# THE DIRECTOR'S MESSAGE

UAW Family,

In 1970, UAW President Walter Reuther said, "There's a direct relationship between the ballot box and the bread box, and what the union fights for and wins at the bargaining table can be taken away in the legislative halls". Now, breadboxes are no longer as popular as they were during that era, but the meaning behind Reuther's words is as relevant now as ever.



What he was really saying with these famous words was that how we vote directly impacts not only our finances, but how we care for ourselves and our families. Local union and national bargaining teams can negotiate the best contracts possible, but if the politicians that are elected to office are not on our side, they can pass legislation that overrides our hard-fought gains.

This is why the UAW and other labor organizations must be involved in politics. Like any institution, it is our responsibility to work to elect politicians who believe what we believe and who will fight for our members.

In May, the UAW held our biennial National CAP Conference in National Harbor, MD. Politically involved members from all over the country attended in order to receive education about the issues, hear from speakers, and lobby their representatives about topics that are important to working people.
