Bus #3 Cleveland – Maumee, OH – Black Lake

Following UAW guidelines in order to park at your departure/pick-up location your vehicles must be made in North America by union members with a VIN number starting with a 1, 2, 4 or 5. (This number can be found on the driver's side dash-board of the vehicle.)

A confirmation letter will be sent confirming your reservation, location pick-up and departure time once your registration form has been received and **confirmed**; this will be the only communication you will receive. Busses do leave promptly at the stated time. Should you have to cancel please notify our office immediately in order to accommodate in cases of a wait list. Also, Black Lake is now charging for no shows, therefore it is imperative that the Region 2B office be notified.

All retirees *must* travel to the center by the buses provided unless otherwise approved by the Retired Worker Representative, Raye Ohl.

For delegates travelling to the bus pick-up location, the driver of the vehicle only will be paid 58 cents/mile to and from your home. Everyone on the bus (delegates and spouses) will be reimbursed \$10 each way for lunch.

Attendance is mandatory at all sessions. Retirees and spouses are required to attend all morning classes and attendance is taken daily. Retirees are free to enjoy every afternoon off and bus trips to Mackinac City and a casino are planned accordingly.
