# **Unemployment Compensation and Supplemental Unemployment Benefits**

Each state has separate rules and processes to apply for Unemployment Compensation. If you have questions on how to file for Unemployment and Supplemental Unemployment Benefits (SUB), please go to dashboard or call your Local Union Benefits Representative.

#### Supplemental Unemployment Benefits (SUB) Duration of Benefit

Traditional Employee Weeks for COUNTER L/O (Indefinite Layoffs)	
•1 to 10 Years - 26 Weeks	
•10 to 20 Years - 39 Weeks	
•20+ Years - 52 Weeks	

New Hire HBU Employee (Hired on or after 10/29/2007) Weeks for Counter L/O (Indefinite Layoffs	
•1 to 3 Years - 13 Weeks	
•3+ years - 26 Weeks

#### **Continuation of Coverage**
