The Region 2B, UAW Advisory Council Meetings (Chaplaincy, Civil & Human Rights, Community Services, Education, IPS/Competitive Shops, Organizing, Skilled Trades, Technical Office & Professional (TOP), Union Label, Veterans and Women's) will be held on Monday, October 26 through Wednesday, October 28, 2026, **at the new Region 2B Headquarters, located at 1789 Indian Wood Circle, Maumee, OH 43537.**

The purpose and agenda for the Advisory Council meetings will be to discuss goals and missions, discuss business of the Advisory Council and plan the Spring 2027 Advisory Council meetings.

Registration will be held on Monday, October 26th between 11 a.m. and 1 p.m. The plenary session will begin at 1 to 4 p.m. There will be a hospitality reception on Monday from 5 to 6 p.m. followed by dinner at 6 p.m., and continue the hospitality reception from 7 to 8 p.m.

A Registration Fee of \$210.00 per delegate will be charged. In addition, due to the new policies, a fee of \$76.00 must be charged per spouse/guest. Registration fees can be submitted through LUIS. Blocks of rooms have been reserved at several area hotels. Please see the attached hotel listings and links. If you are staying overnight, it is important that you make your hotel room reservations as soon as possible, but in no event later than the cut-off dates listed. **Due to high demand, hotel rooms after these dates may not be available.**

Reservations are the responsibility of the Local Union/Unit/Council/Chapter sending the delegate. Travel days are Monday, October 26th and return travel day on Wednesday, October 28th.

All lost time and expenses are the responsibility of the Local/Unit/Chapter/Council sending delegate. Per diems will be as follows: Monday \$26, Tuesday \$29 and Wednesday \$13.00 (If traveling over 100 miles, \$25 travel day minus breakfast).
