As I write this article there is heavy snow falling. I take for granted that when I wake up and drive to work the roads will be plowed and safe to travel on. If corporations are allowed to continue to use the bankruptcy court to gut their

workers' wages and benefits the tax base will be eroded. Those governmental services that we take for granted may not always be there. City and county workers plow our roads, remove our trash, protect our families through the police, sheriff and fire departments. They sanitize the water and serve the public in many other ways. The taxes that are paid by working people are how these services are funded. If we make less money we also pay less into our City, County, State and Federal taxes. Most of the elite executives that want to reward themselves for running their companies into the ground at our expense don't live in the communities that we do. So the small amount of taxes that they pay does not go into our community.

January 5, 2006 is the date Delphi will be asking the bankruptcy court to allow them to pay the exorbitant bonuses to their top executives. Hopefully, the court will see how unfair this is.

The way we fight these injustices is on the political front through the CAP Committee and V-CAP. I am very proud to say that V-CAP donations are up 9% in the Region. Obviously, more members are seeing how important it is to give to CAP.

UAW members are the greatest! Within Region 3 (Indiana & Kentucky) we collected \$86,307.99 for the Hurricane Katrina Relief Fund. We also raised \$58,795.00 in the Region for Make-A-Wish. This money was raised through the Poker Run and the Golf Tournament. Locally, the Local 292 team again raised the most money for America's Walk for Diabetes. We raised \$9,355.00. When added to the other teams, the Kokomo Walk raised almost \$50,000.00. I am sure there are many other charities that Local 292 members support in a variety of ways. I congratulate you all; especially, in these difficult times it is still important to help others less fortunate than we are.

Today, more than ever brothers and sisters, we need to ban together and rekindle King's Dream and Reuther's Vision by continuing to strive to make them a reality.


