There has been a lot happen between last month and this month. The Special Attrition Package was announced, a few days later Delphi filed 1113 and 1114 motions in the Bankruptcy Court to terminate our Contracts and Benefits, the Union and Management rolled out the Special Attrition Package to the membership at the Union Hall at which over 1,000 of our members attended. This is Delphi's package to roll out, but the UAW International Union and Delphi agreed to roll it out to the membership together to make sure all our member's questions were answered correctly. Our UAW Servicing Representative Mike Grimes and out of the UAW Benefits Department, Ron Graham, were at the meetings and did a great job answering questions. The deadline for signing up for one of the retirement packages is June 1, 2006.

On May 1, 2006 we will get 40 transfers from Anderson, Indiana. In addition, we are trying to get 40 on May 8th and 40 on May 15th. By the time this article is printed we will have started a process for all Kokomo Delphi employees, hourly and salary, to refer someone to be hired here at Kokomo Delphi. After the referral process, they will begin to interview the referrals and drug test. Hopefully we will begin to hire these people off the street by June 19, 2006. We may end up hiring up to 800 people off the street.

I will be in Detroit the week of May 1, 2006 to attend our Subcouncil Conferences, both Production and Skilled. Anything new I receive in the meetings I will get to this membership as soon as possible. I want to thank all of you for your support.

President's Report

Sona Camp, President



The attrition package has been presented since last month's Antenna. I know there are so many mixed feelings that we are all going through. I hate that Delphi is putting us through this. The decisions that have to be made are tough ones and everyone has a different set of circumstances that have to be considered.

I would like to commend the International Union for doing a good

job of negotiating options for all of us. I was amazed that Delphi employees were given the retirement incentive given the financial constraints that Delphi says it has. Even the younger seniority members that never worked for GM now has a right to flow back to GM. If we didn't have a Union, Delphi would have implemented the changes they are proposing and we couldn't even have fought against it. CEO Steve Miller, as we know, is trying to circumvent the negotiation process through the bankruptcy court. There needs to be changes in the Bankruptcy Laws to protect the workers. Our Democrat Senator from Indiana Evan Bayh and Congressman John Convers, Jr. (D-Mi.) has introduced a bankruptcy reform bill designed to eliminate some of the abuses that have occurred in the Delphi and other recent corporate bankruptcies. This bill is entitled the "Fairness and Accountability in Reorganizations Act of 2006" (FAR). The bill numbers are S. 2556 and H.R. 5113.

This bill addresses two key issues. First, it closes some of the loopholes that have allowed executives at Delphi and other companies to propose huge bonuses and other forms of lucrative executive compensation; at the same time they are using the bankruptcy process to try to slash wages and benefits for workers and retirees. As a matter of fundamental fairness, management should not be allowed to enrich themselves on the backs of workers and retirees. There should be equality of sacrifice among all of the stakeholders.

Second, the bill requires the bankruptcy judge to take into consideration a company's foreign operations, as well as its domestic ones, in ruling on section 1113 and 1114 motions to reject collective bargaining agreements and retiree health benefits. Corporations should not be allowed to shift resources and production to profitable overseas operations, at the same time they are pleading poverty in an attempt to cut wages, benefits and jobs in their U.S. operations.

The UAW and other unions are urging Representatives and Senators to show their support for these bankruptcy reforms by cosponsoring the Bayh-Conyers bill (S. 2556; H.R. 5113).

Please encourage your friends and neighbors along with other UAW activists to contact their Representatives and Senators immediately and urge them to stand up against bankruptcy abuses by Delphi and other corporations by supporting this important legislation.

We always talk about how very important it is that you vote for the candidates that support labor. Obviously, Senator Evan Bayh is on our side. I find it interesting that the four UAW plants that Delphi is going to keep open are in States that had Senators, Governors or Congressmen that were vocal about their views against the Delphi bankruptcy. They wrote letters to CEO Steve Miller in our support and/or introduced legislation supporting the working class people at Delphi. The States they are from are Indiana (Sen. Evan Bayh-D), New York (Sen. Hillary Clinton–D) and Michigan (Gov Grantholm – D, and John Conyers, D - Mi). When we go to the polls to cast our vote, we need to remember who was on our side when we needed them.

Learn The Facts Before You Vote

With the upcoming elections in November one needs to find out who truly looks out for Americans, before we cast a vote for any candidate. A blatant example of hiding behind a slogan "The American Way" is the past president of Amway Corporation, Dick DeVos.

Dick DeVos was president of Amway Corporation from 1998 to 2000. During that time he laid off 1400 workers and then turned around and invested over 200 million dollars in NEW manufacturing plants in China. Mr. DeVos's strategy reaped profits for Amway, but we Americans lost 1400 more jobs for the sake of profits for a few.

Amway's company's' slogan "The American Way" should be an insult to all hardworking Americans. If we really looked at the individuals running for public office in this country based on their track record and ties to corporations we would be able to exclude many who campaign and hide behind a façade of "The American Way." We need to ask and find out about candidates who help give our jobs to countries with extensive

labor and human rights violations and those countries which continue the exploitation of their workforces.

The candidate that supports the outsourcing of these and other jobs has a direct impact on the True American Way. Dick DeVos is not a candidate in Indiana or the National Election at this time, but who knows if he wins the Governor's race in Michigan he too could soon run for President not unlike the former Governor of Texas George W. Bush.

As a voter our True American Way has always included a standard of living second to none, a safe and clean workplace, high standard labor laws, and a clean environment of ALL to live in.

As you enter the polls on Election Day make sure you have educated yourself on the candidate's platform and their stance of the American Worker. Our future, your future, and your children's future are in the hands of each candidate that you elect.

Recording Secretary's Report

This is a partial listing of Quality/Safety recalls for 2005 vehicles sold in the United States.

Hyundai sold 252,851 vehicles with 11 recalls effecting 321,029 vehicles. This equals to 1.93 recalls per vehicle.

Kia sold 275,851 vehicles with 12 recalls effecting 532,898 vehicles. This equates to 1.93 recalls per vehicle sold.

Toyota sold 2.6 million vehicles with 23 recalls effecting 2,225,776. This equates to 0.856 recalls per vehicle sold (Toyota's above recall number does not include the 75,000 hybrids recalled).

Daimler Chrysler sold 2,304,833 vehicles with 9 recalls effecting 765,777 vehicles. This equates to 0.332 recalls per vehicle sold.

Ford sold 3,315,019 vehicles with 17 recalls effecting 6,005,309 vehicles. This equates to 1.81 recalls per vehicle sold.

GM sold 5.4 million vehicles with 30 recalls effecting 5,044,162 vehicles. This equates to 0.93 recalls per vehicle sold.

Based on the quality/safety recall information, a Hyundai vehicle owner is now likely to need a warranty than the owners of American made/Union made vehicles.

For every Ford, GM, Daimler Chrysler employee in the U.S. there are approximately 5 more workers indirectly employed in the U.S. automotive market. Just ask any ex-employee of companies that have closed due to the weak U.S. automotive market.

So, as you drive your foreign vehicle in for a recall – past a closed plant - just remember your purchase helped close those plants.
