At the time of this writing our Local reached a Tentative Agreement and held informational meetings but has not been ratified by our membership.

The Committee and I want to wish everyone a Merry Christmas and a Happy New Year!

2023 has been an eventful year for all of us. We all have gone through some very uncertain times. From Negotiations to the strike, then layoffs due to the strike. It was a lot that most of us have never experienced before. I want to Thank the entire 863 Membership for your patience and support, and for having trust in our Local and National Leadership as we made it through those uncertain times.

Our National Contract was ratified on 11-17-23 and went into effect on 11-20-23. I want to congratulate all the recent TFT'S (118) that were converted to full-time seniority status. That leaves us with 1 TFT class remaining. The Bargaining Committee, and I are working with the Company to try and get the final class converted very soon. Everyone should have received the 11% pay increase, and on December 1st, everyone should have received their ratification bonus. Anyone that was laid off whether it was for 1 week or 2 weeks should have received their Strike Settlement Money as well. Our COLA (.21) should show up on members checks week ending 12-10-23, and all the retroactive pay to Oct. 23 will be paid no later than pay ending 12-17-23.

The Bargaining Committee and I are proud to announce that we came to a Local Tentative Agreement with the Company on 11-21-23. Everyone should have seen the highlight pages by now, we hope the Membership will approve this Agreement as we feel we addressed our member's needs. I want

I've been getting a lot of questions on hiring. No hiring will take place until after the first of the year.

I want to wish everyone a Merry Christmas, Happy Holidays, and Happy New Year. We are very excited for the new changes in the Benefits for our Retirees and our Active members beginning January 1, 2024. I do want you all to know that since the ratification of the contract that my office has been extremely busy. I am running about 5-7 days on call back time; this is due to high retirement volume and people coming in the office with questions about the new contract benefit changes. I am asking that everyone please be patient at this time. This high volume could last for the next few months running into the March 2024 timeframe. If you have an emergency and can not wait for a call back, please call the NESC at 1-800-248-4444, they can assist with most issues. When you leave a voice message be sure to leave your name, number, and a brief description of your concern. I will try to call back on priority calls first.

Attention Active Employees Only:

Those of you that are wanting to retire, that meet the eligibility guidelines which are:

- a fulltime seniority employee who hired prior to November 19, 2007.
- 30+ years of credited service time.
- 85 points with years of service and age combined.
- 55 years of age with 10 years of service or more.

You will be receiving a letter in the mail from the Ford Benefits office with information about the sign-up period for the Special Retirement Incentive (SRI) \$50,000, do not miss this window to sign up. The UAW

office will be getting this information by December 11, 2023. If you are retiring January 1, 2024, you will need to come back to the plant to sign-up during the window. **DO NOT MISS THE WINDOW!!**

There are several ways to initiate your pension request:

- 1) Call the NESC 1-800-248-4444 and give them the date you wish to retire they will mail you retirement paperwork that you will need to fill out and resubmit.
- 2) Go online at <u>ww.myfordbenefits.com</u> > Building Savings and Retirement > Retirement Hub > Initiate Pension complete the online application and submit with online signature (press of buttons).
- 3) You can make an appointment in my office for a one-on-one sit down if you need assistance in submitting for your pension/retirement.

You will need to complete the clearance process for checkout from the Plant. Those forms can be picked up in the Benefit Office or the HR Labor Relations department.

Welcome to all our newly transitioned employees. Please remember to stay in network with your doctors and facilities. Make sure you call the NESC to make your insurance elections and add your dependents. Make sure you get your Beneficiaries on file with MetLife for your new Basic and/or Optional Life Insurance options.

Attention Retirees Only:

Details on the 2024 Over-the-Counter Benefit WATCH YOUR MAIL for the "FLEX" card & Catalog. In late December, every eligible member in a household will receive an OTC "FLEX CARD" in the mail for purchasing health and wellness products at any of the more than 68,000 retailers where you see the OTC Network logo. This card is pre-loaded and will require activation before the first use. Please read all the information mailed to you carefully.

<u>IMPORTANT</u>: <u>Cards will not</u> be issued annually so keep this card in a safe place just as you would your credit or debit card.

If you have a problem verifying eligibility to activate your card or do not receive a "FLEX CARD" by December 31, 2023 contact the **Retiree Health Care Connect** (RHCC) at 1-866-637-7555 - Monday through Friday 8:30 a.m. – 4:30 p.m. Eastern time. Also, place your catalog in a safe place so you can refer to it when needed – Replacement catalogs will not be available due to printing and shipping cost.

Other Important Information:

- You must order any remaining allowance from your 2023 Trust OTC benefit by December 15, 2023.
- The current Trust OTC vendor will not take orders after this date Unused dollars will be forfeited.
- You will be automatically enrolled into this program; no action is required.
- The OTC allowance resets each year, and your balance will NOT carry over to the following year so be sure to use all your allowance within the 2024 calendar year.
- You will not receive a catalog in future years. Please use the website, mobile app, or instore option for a complete view of items available under this benefit.
- Cards will not be sent every year, the card you receive will be reloaded annually so please do not throw it away after you have used your full benefit amount in any year.
- All OTC benefit communications material will display the UAW Trust OTC logo.

IMPORTANT INFORMATION:

I have mentioned this time and time again, when you are going for Physical Therapy and you have National PPO BCBS plan you MUST go in

You will be paying out of pocket if you go out of network. It is imperative that you stay in network with all your coverages. It is your responsibility to make sure you are going to an IN-NETWORK provider. If you have any doubts, go to the websites, and verify or call the number of the back of your cards.

In this issue I want to provide some information on what CAP, the Community Action Program, is and why it is important for our members to support the program.

V-CAP is the UAW's political action program, which includes the Union's PAC (Political Action Committee). The PAC fund is made up of voluntary contributions from UAW members, both active and retired. The money is used to support political candidates, regardless of party affliation, who are pro labor and have earned the endorsement of the UAW Community Action Program.

The Community Action Program of the UAW is the union's non-partisan political arm. CAP educates members, both active and retired, on political issues that affect them and their families. As part of this effort, CAP endorses candidates who have a record of backing legislation that supports unions and addresses issues facing working families. It is important to remember CAP is not tied to any political party.

WHY SUPPORT V-CAP?

Whether it is taxes, trade policies, retirement security, healthcare, education or infrastructure, politics affects our daily lives. That's why it is essential for working families to make our voices heard in local, state and national politics by supporting candidates who support labor. An example of a policy that has affected some of our members recently is not being able to file for unemployment because you were laid off due to a strike.

DOES V-CAP USE UNION DUES?

Are Union Dues Used for Federal Campaign Contributions? No. That is a common misunderstanding. The fact is federal, and most state, election laws prohibit unions from contributing members' dues to political candidates. The only money that can be used for contributions to candidates is money members voluntarily contribute to V-CAP.

If you are not currently contributing to V-CAP, I encourage you to consider contributing so we can continue to promote political candidates and issues that are PRO labor.

WHAT IS VCAP?

From trade policy to health care, education to retirement security, taxes to roads and highways, *politics affects our daily lives.*

That is why it is essential for working families to make our voices heard in local, state and national politics. And one of the most effective ways to do that is by contributing to our union's voluntary political action committee — UAW V-CAP

Our contributions to UAW V-CAP are used to support the campaigns of pro-working family candidates who have earned the endorsement of the UAW Community Action Program


