If your retirement date was not met and you want to retire the first day of the following month you do not need to do anything.

If your retirement date was not met and you wish to retire on a different date. other than the first day of the following month, you must contact Labor Relations and your UAW Benefit Rep. AS SOON AS POSSIBLE.

Example: July exit date was not met and instead of retiring August 1, 2006 you decide to retire December 31, 2006.

President's Report

Sona Camp, President



Since last month we have had a lot of new hires added to the membership at Local 292. I'd like to welcome you all and encourage you to become involved with your Union. You are the future of our Union. Our membership meetings are held the 3rd Thursday of every month at 7:30 A.M., 12:30 P.M. and 4 P.M. Please come to the meeting that is most convenient for you. This is where the business of our Local is conducted. In the next few months there will be elections held for various Union jobs due to some officers leaving to flow back to GM or leaving on the attrition package. These special elections will be posted on the Union information bulletin boards with the meeting notices.

The emotional strains we are all going through are difficult. The company wants us to leave and then they won't let us go. At least half of the people that signed for the retirement weren't ready to retire yet but felt forced into it by Delphi. Others have to uproot their family to preserve their pay and benefits. And during this time, 50 new hires are being brought in every week for us to train before we leave. The new hires are not the cause of the problem. Delphi has caused this mess. Remember what it was like when you hired in and how you were afraid of doing something wrong during your first 90 days. These new hires are going through something none of us had to endure. They are classified as temporary. The local union did not agree to this and we are trying as hard as we can to get them made permanent. We feel that this will happen. If you happen to be working with a new member try to help them to feel welcome.

What Delphi has inflicted on us was unimaginable just a short time ago. The people we elected in Washington allowed it to happen. We need to remember what few friends we do have there. One is our own Senator Evan Bayh who introduced legislation to reform the laws governing corporate bankruptcy. This law would prohibit companies from investing overseas with US profits then filing bankruptcy only on their US plants as Delphi did. It would also ban the obscene corporate bonuses during bankruptcy. Senator Bayh is going to be in Kokomo at IUK on Aug 11th for a job fair. Let's all go and tell him how much we appreciate what he is doing for working class people in America!



Shop Chairman's Report

In our handbill circulated to the membership on 7-13-06, we pointed out several issues with management that needed to be resolved.

- 1. We had a disagreement on the agenda of the orientation for our temporary new hire employees, because of little, if any, input from our local union as to what was presented to our new members. That has been corrected and our elected and appointed union officials will again be involved in this orientation process beginning Monday, August 7, 2006.
- 2. Management completely ignored our transfer agreement and placed the new hires in primary and secondary openings. This has been corrected and all primary and secondary openings will be filled by seniority transfer requests and the new hires will be placed in the third opening. All employees that were violated during these four weeks, starting with the week of July 10, 2006, will be paid a monetary settlement. When you are given a paper signed by management authorizing your retirement date and you are within sixty days of that date, you will not be allowed to transfer per your request, but you will be paid the higher rate of pay until you retire within those sixty days.
- 3. Management removed the nurse on third shift. That has been resolved. Management hired another nurse and a nurse has again been placed on third shift to medicate both hourly and salary employees.
- 4. Management reduced the number of security guards at this site and therefore stopped opening our three most heavily traveled gates 24 hours per day, 7 days per week (Gates 8 West, 9 West and Goyer Road). This has been resolved by management hiring seven new security guards and now keeping those gates open.
- 5. Management has refused to provide nurse coverage on weekend overtime. This has NOT been resolved, but we are in discussions concerning the number of employees working on a Saturday or Sunday that would require coverage.

Our active membership totals 2200 members. 1163 members agreed to the Special Attrition Package. 217 members have flowed back, or agreed to flow back to GM. It is anticipated that approximately 100 members will agree to the 26 year grow-in retirement and the buy-outs of \$70,000 and \$140,000 packages. Over 400 more members are anticipated to flow back to GM. If all this does happen, there will only be approximately 300 members that are here today with seniority around this time next year with about 1700 new hires.

There have been 300 temporary new hires hired so far and management's plan is to hire 50 more per week through the end of the year, which would equal a total of 1400 by years end.

All of our members gaining seniority between October 1999 and October 2005, that flow back to GM, will start day one seniority at GM, but benefits will be based on your seniority you had at Delphi (vacation, etc.).

We will handbill any future information received from the National Parties concerning the bankruptcy or our employment at Kokomo Delphi as soon as I receive it.

What will it take for you to vote in the upcoming election? Have we lost enough American jobs? It doesn't seem right to have a family that goes to work each day, pays there taxes to have to have to worry about an injury or illness to a loved one bankrupting the family. It doesn't seem right that the top one percent of society's wages in 2003 went up nearly \$49,000 a year- that's more than the total income for most American households.

I will give the country club crowd a resounding atta-boy. Before each election you pull out the same old decisive issues to your advantage. You know guns, race, abortion, and gays to name a few. I honestly don't know how much more of this prosperity we can stand. If there is a bright spot on the horizon it has to be Indiana State Representative candidate Ron Herrell. Here is a man of the highest moral values and integrity.

Ron Herrell has spent his entire adult life serving our community. He served in the United States Army as a medic, serving in Korea with the 377th Medivac Unit. Upon his honorable discharge, Ron went to work at Howard Community Hospital as an Emergency Medical Technician. He then became a Kokomo firefighter, serving for 27 years. Ron Herrell also served as our District 30 State Representative for three terms, from 1998 to 2004.

When ever people talk to Ron about Indiana's economic development efforts, he is quick to mention our state's resource: the hard working men and women who are the envy of other states across the world. When people refer to Hoosier values that are the pride of our state, they are talking about the dedicated workers who make the goods, provide the services, and serve our communities as volunteers.

This is a perfect example of what Pro working family politicians can mean to us in labor. Do you honestly think Mitch Daniels would have taken on Delphi and reversed the order? I say no way!

In December 2005, when the local unions held a 2000 plus member rally at the Johanning Center, Ron Herrell was there supporting us. Did his opponent show up to support Delphi workers or did any of his republican friends show up? No. If you have ever attended any of the UAW retiree picnics, you have seen Ron, serving drinks and helping with the needs of our senior members. One can see by Ron's actions and service in our community that he has a servant's heart.

Ron Harrell's opponent, Representative John Smith, serves as a rubber stamp for anything Governor Daniels or the Republican leadership wants. When the Governor wanted Daylight Savings Time, Smith rubber stamped the Governor's request, rather than placing the initiative on the ballot and letting the people of Indiana have a voice. When we see where management is leading our businesses, one would ask why we would sell a
